

Under the “WIN \$5,000 TOWARDS YOUR DREAM WEDDING” Contest (the “Contest”), organized by Tip Top (“Organizer”) doing business as Grafton Apparel (“Grafton Apparel”) and taking place between Monday September 8, 2025 at 08:00 am EST and, Sunday December 7, 2025 at 11:59 p.m. EST, the undersigned (the “Winner”) will be chosen at random in a draw that will be held the week of December 22, 2025.

1. ELIGIBILITY

NO PURCHASE IS NECESSARY TO ENTER THIS CONTEST

The Contest is open to all residents of Canada who have reached the age of majority in their province or territory of residence by the Contest Opening Date, except for employees, agents and representatives of the Organizer, its subsidiaries, affiliates, affiliated companies, advertising or promotion agencies, the suppliers of material, prizes and services related to this Contest, and any other stakeholder directly related to the holding of the Contest, as well as the members of their immediate family (father, mother, brothers, sisters, children and legal or de facto spouse) and anyone with whom these employees, representatives and agents reside.

2. HOW TO ENTER

2.1. No purchase necessary

2.1.1. To enter the Contest, the contestant (the “Contestant”) must fill out the Contest Form and provide the following mandatory information: (i) first name; (ii) last name; (iii) email address; (iv) that they have read and understood the contest rules; and (v) that they agree to receive future communications from Tip Top and Today’s Bride. The following are all valid ways to enter the Contest, but only one method of entry is allowed per Contestant:

2.1.1.b. QR code form, hosted by the Organizer via Viralsweep; or

2.1.2. The Contestant who has completed the online entry form is eligible for the Prize (defined below) draw, to be held the week of December 22, 2025. Limit of one (1) entry per person.

3. PRIZE

The Winner hereby acknowledges and accepts the Prize consisting of one (1) cash prize of \$5,000 CAD, paid by EFT (Electronic Funds Transfer). The Prize offered must be accepted as awarded and is not exchangeable, refundable, or transferable. In the event the Prize is not accepted in accordance with its attached conditions, the Prize will be deemed to be forfeited. Grafton Apparel is not responsible for lost or stolen prizes.

4. DRAW

4.1 One (1) random draw will be held from all eligible entries received between the Contest opening date (Monday September 8, 2025, 08:00 am EST) and the Contest closing date (Sunday December 7, 2025, 11:59 p.m. EST). The draw shall be held the week of December 22, 2025, in the offices of Grafton Apparel, 115 Applewood Crescent, Concord, ON, L4K 5C1. The odds of winning depend on the total number of eligible Entries submitted and received during the Contest Period.

4.2 The drawn name must be subscribed to the email database to qualify to be the winner.

5. PRIZE CLAIM

5.1 In order to be declared a winner, the selected Contestant must:

5.1.1 Fill in the entry form and complete and answer all the compulsory fields.

5.1.2 Be reached by telephone or email by the Organizer of the Contest within forty-eight (48) hours after the draw and correctly answer the mathematical skill-testing question that will be asked. If it is impossible to reach the selected Contestant by telephone or email within forty-eight (48) hours after the draw, all rights to the Prize will be forfeited and another entry will be drawn. If it is impossible to reach the second selected Contestant by telephone or email within forty-eight (48) hours of the draw of the second entry, all rights to the Prize will be forfeited and another entry will be drawn. If it is impossible to reach the third selected Contestant by telephone or email within forty-eight (48) hours of the draw of the third entry, the prize will be forfeited.

5.1.3 Complete and sign the declaration and waiver form (the “Declaration Form”) which will be transmitted by the Organizer and must be returned to the Organizer of the Contest within three (3) business days of receipt.

5.2 The winner will be named within thirty (30) days following the draw date for the Prize.

5.3 In default of observing any of the conditions mentioned above or any other conditions stipulated in these Rules, the selected Contestant will be disqualified and the Prize that would have been awarded will be forfeited. Within the days following receipt of the duly completed Declaration Form, the Organizer of the Contest will contact the winner to inform him/her of how to claim the Prize.

7.1.3. Conducting a survey regarding the effectiveness of the website, advertising and sales efforts made by the Organizer.
